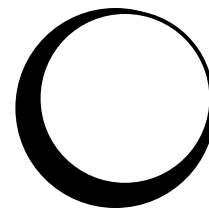


MANUSCRIPT CHECK LIST

As you prepare to submit your manuscript, please go through this list and check-off each item as it is completed. **Failure to conform to the format requirements will result in your paper being sent back to you, and a delay in publication.**



ACTA PRESS

- 1. The title is in upper case letters and centered on the page. The author's names are centered under the title.
- 2. Information about the author's department, university, university address, and e-mail address is provided. Phone and fax numbers appear only on the cover letter. If information is different for each author, multiple asterisks are used.
- 3. Headings and subheadings are flush left and **set in boldface** - including "**Abstract**" and "**Key Words**", and are in upper and lower case letters.
- 4. Numbering of sections begins with the introduction, which is given the number 1. (no Roman numerals). A period appears after the number.
- 5. For **subheadings**, the numbers used are 1.1, 1.2, etc. If a subsection must be further divided, the numbers 1.1.1, 1.1.2, etc. are used and the number and associated title are *set in italics* instead of boldface.
- 6. The first paragraph following a heading or subheading is flush left and all paragraphs that follow are indented.
- 7. Figure captions appear below the figure, are flush left, and are in lower case letters. When referring to a figure in the body of the text, the abbreviation "Fig." is used.
- 8. Table captions appear centered above the table in upper and lower case letters. When referring to a table in the body of the text, no abbreviation is used (i.e., Table 1).
- 9. Equations are numbered (1), (2), etc. When referring to an equation in the body of the text, only the number enclosed in round brackets is used. A colon is inserted before an equation is presented, but there is no punctuation following the equation.
- 10. British/Canadian spelling is adopted. Note especially the spelling of "modelling" and "catalogue". Acronyms are spelled out at first mention, but not thereafter. Manuscript is in **double-spaced, single-column** format.
- 11. An acknowledgement section can be presented after the conclusion, if desired.
- 12. References are numbered and listed in the reference section **in the order that they appear in the text**, NOT in alphabetical order by author's names. When referring to a source in the text, only the numeral enclosed in square brackets is used for identification (i.e., [1]). No reference to the author is necessary. All references are collected in a reference section at the end of the main text in the following format:

Journal Papers:

[1] M Ozaki, Y. Adachi, Y. Iwahori, & N. Ishii, Application of fuzzy theory to writer recognition of Chinese characters, *International Journal of Modelling and Simulation*, 18(2), 1998, 112-116

Note that journal title and volume number (but not issue number) are set in italics.

Books:

[2] R.E. Moore, *Interval analysis* (Englewood Cliffs, NJ: Prentice-Hall, 1966).

Note that the title of the book is in lower case letters and italicized. There is no comma following the title. Place of publication and publisher are given.

Proceedings Papers:

[3] W.J. Book, Modelling design and control of flexible manipulator arms: A tutorial review, *Proc. 29th IEEE Conf. on Decision and Control*, San Francisco, CA, 1990, 500-506.

Note that the proceedings title is set in italics.

- 13. Biographies of authors are provided (120-150 words). The authors' names are *set in italics*.
